
INFORMED CONSENT FOR CONSULTATION SERVICES

Out-of-State Clients — Informational Consultation Only

PLEASE READ CAREFULLY BEFORE SIGNING

This document governs the consultation relationship between you and Chad Oler, ND, for clients who reside outside the State of Wisconsin. Because Dr. Oler holds a Limited-Scope Naturopathic Doctor license issued by the State of Wisconsin only, he is not licensed to practice naturopathic medicine in your state of residence. The services described in this document are therefore provided as informational consultation only — not as naturopathic medical treatment or medical care — and do not establish a doctor–patient relationship for purposes of diagnosing, treating, or managing any medical condition.

1. About Your Consultant

Consultation services are provided by Chad Oler, ND, a Licensed Limited-Scope Naturopathic Doctor in the State of Wisconsin (License #6002-171), issued by the Wisconsin Naturopathic Medicine Examining Board under Wis. Stat. § 466.04(2). Dr. Oler has experience in naturopathic functional health, clinical nutrition, amino acid therapy, botanical medicine, and lifestyle counseling.

Dr. Oler is not licensed to practice naturopathic medicine or any other form of medicine in your state of residence. This consultation is provided solely from Wisconsin and is governed by Wisconsin law.

2. Nature and Scope of Consultation

Consultation services provided to out-of-state clients are informational and educational in nature. They are designed to help you better understand your health concerns and wellness options, explore approaches that may not be available to you locally, and make more informed decisions in partnership with your primary healthcare provider. Consultations may include any of the following:

The following limitations apply to all consultations with out-of-state clients and cannot be waived:

via telehealth or other electronic means.

- This consultation does not establish a doctor-patient relationship for purposes of diagnosis or treatment.
- Dr. Oler will not diagnose any medical condition, prescribe any medication, or advise you to discontinue or change any treatment prescribed by a licensed healthcare provider.
- Information and guidance provided during consultation does not replace a comprehensive evaluation by a licensed healthcare provider who can physically examine you and review your complete medical history. Dr. Oler does not have access to your complete medical history unless you provide it, and he cannot perform a physical examination.

4. Your Relationship with Your Primary Healthcare Provider

These consultation services are intended to complement — not replace — the care you receive from your primary physician, specialist, or other licensed healthcare provider in your state. You are strongly encouraged to:

5. A Note About Amino Acid Therapy

A significant area of Dr. Oler's consultation work involves amino acid therapy as it relates to neurotransmitter function. This approach explores the role of specific amino acid precursors in supporting the body's natural production of neurotransmitters such as serotonin, dopamine, and others. Conditions where this approach is often discussed in the literature and among practitioners include Parkinson's disease, depression, anxiety, migraine headaches, and related conditions.

Amino acid therapy as discussed in consultations is educational and informational in nature. It is not intended as a substitute for your neurologist's, psychiatrist's, or other specialist's care. Amino acid supplements — like all nutritional supplements — can interact with medications, and it is essential that you disclose any supplement protocols to your prescribing physician. Dr. Oler will highlight potential interactions or contraindications of which he is aware but cannot guarantee comprehensive knowledge of your full medical picture.
